NOTICE OF PUBLIC AUCTION ON MARCH 15 – 18, 2014 OF TAX-DEFAULTED PROPERTY FOR DELINOUENT TAXES

On December 3, 2013, I, Edward J. Lamb, Glenn County Tax Collector, was directed to conduct a public auction sale by the board of supervisors of Glenn County, California. The tax-defaulted properties listed below are subject to the tax collector's power of sale and have been approved for sale by a resolution dated December 3, 2013 (or prior) of the Glenn County Board of Supervisors.

The sale will be conducted at the internet auction website www.bid4assets.com, starting Saturday, March 15, 2014 at 8:00 a.m. PT through Tuesday, March 18, 2014, as a public auction to the highest bidder for not less than the minimum bid as shown on this notice. If no bids are received on a parcel during the course of the sale, the minimum bid may be lowered, at the tax collector's discretion. Research the item prior to bidding. Due diligence research is incumbent on the bidder. The winning bidder is legally obligated to purchase the item.

Only bids submitted via the Internet will be accepted. Pre-registration is required. Register on-line at www.bid4assets.com. Bidders must submit a refundable deposit of \$1,000.00 plus \$35.00 processing fee to participate in the auction. Bid deposits must be in the form of a wire transfer, certified check, or money order and must be in the custody of Bid4Assets no later than Tuesday, March 11, 2014 at 1:00 p.m. PT or 4:00 p.m. ET. The deposit will be applied to the successful bidder's purchase price. Full payment and deed information indicating how title should be vested is required within 72 hours after the end of the sale. Only wires, certified checks, and money orders will be accepted. A California transfer tax will be added to and collected with the purchase price and is calculated at \$.55 per each \$500 or fraction thereof.

Excess proceeds are the dollar amount of the highest bid in excess of the liens and costs of the sale. Notice will be given to parties of interest, pursuant to law, if excess proceeds of \$150 or greater result from the sale.
